Subject: Minutes of the Meeting of Technical Evaluation Committee (TEC) held on 08/11/2024 at 2:30 PM under the Chairmanship of Addl. Chief Secretary (IT), to examine the IT related proposals of various Departments of Govt. of NCT of Delhi.

- V. The proposals of the various Departments as per meeting agenda and decisions taken/advice of the Technical Evaluation Committee are described below:

1. Directorate of Education, GNCTD F.No: DE.45/CEP/314/Addl.File CD No: 043606662

The proposals of the Education Department regarding engagement/continuation of 1068 I.T. Assistants w.e.f. 01/07/2024 and engagement/continuation of 670 I.T. Assistants w.e.f. 01/10/2024 from M/s ICSIL, received with the recommendations of Secretary (Education) were placed in the TEC meeting held on 08/11/2024.

TEC discussed the proposals of the Education Department, as per detail given in the TEC agenda item mentioned in attached Annexure-I. The representatives of the Directorate of Education explained the proposal during the meeting. TEC observed that the Administrative Department has been extending the contracts in the past ignoring recommendation of the TEC and thus in violation of the norms in this context. Hence, TEC cannot accord ex-post facto approval in this case. However, in the public interest, TEC recommend for continuation of the hired manpower in both the proposals-1068 IT Assistants w.e.f. 01/07/2024 and 670 IT Assistants w.e.f. 01/10/2024 till 31 March 2025 with the advice that Department shall

adhere to the previous decisions (MoM of TEC dated 10/06/2020 & 26/09/2022) of the TEC regarding extension of 670 IT Assistants. Furtor, it was re-iterated that this is last chance for according extension of the hired manpower. TEC observed that the requirement of the hired manpower seems of permanent nature, so advised the Administrative Department to pursue for creation of regular post of suitable level and pay scale in consultation with AR Department.

2. <u>Delhi e-Governance Society(DeGS), IT Department,</u>

The proposal of DeGS regarding procurement of 05 high end Desktops and 02 Laptops required for creation and implementation of Unified Data Hub of Delhi was placed before TEC.

TEC discussed the proposal of IT, as per detail given in the TEC agenda item mentioned in attached Annexure-I. Director(DeGS) explained the requirement of high end desktops and laptops. After deliberations, TEC concurred the proposal of procurement of 05 high desktops and 02 laptops through GeMS.

3. IT Department

The proposal of IT Department regarding hiring of 04 technical manpower (01 Database Administrator, 01 UI Developer, 01 API developer and 01 Cloud infra developer.

TEC discussed the proposal of IT, as per detail given in the TEC agenda item mentioned in attached Annexure-I. After deliberations, TEC concurred the proposal of hiring of 04 Technical for the UDH Project from NICSI.

The meeting ended with the Chair thanking to all the participants for their contribution.

VI. The recommendations of TEC are subject to the condition that respective departments shall complete all codal formalities as per GFR 2017, Manual for Procurement of Goods-2022, Delegation on Financial Powers, 2024 and latest instructions issued by IT Department and Finance Department, GNCTD from time to time.

Subject: - Engagement/Continuation of 1068 I.T. Assistants & 670 IT Assistant from M/s ICSIL.

The proposal has been resubmitted by the department with the recommendations of Secretary (Education).

Following has been submitted by the department

1) 1068 I.T. Assistants have been outsourced from M/s ICSIL with the approval Finance Department vide U.O. No. 449/DS3 dated 27.03.20214 & U.O.No. 439/DS3 dated 25.03.2014 initially for period of 02 years.

2) The agreement has been extended from time to time by the competent authority as per F.D

O.M No. F.20/28/2016-AC/634-673 dated 19.08.20216.

3) The latest agreement with M/s ICSIL was extended till 30.06.2024.

- 4) These 1068 IT Assistants are not working against any sanctioned post in DoE, as on date.
- 5) Discontinuation of these 1068 IT Assistants would standstill the smooth functioning of 1068 Govt. schools as the IT Assistants are backbone of Govt. Schools under Directorate of Education, in as much as IT related work/ computer related work is concerned.

6) Department has submitted file for 670 IT Assistants to link up the matter with 1068 IT

Assistants.

7) Department has submitted the duly filled performa as sought by IT Department in the last TEC held in Oct 2024.

Observation of IT Department:

For 1068 IT Assistants:

In light of the matter submitted by the Administrative Department, IT Department observed that:

i. TEC/ IT Department had approved engagement of 568 IT Assistants to be deployed in schools of DoE for effective implementation of MIS project for a period of 04 years vide MoM dated 10.12.2007 w.e.f. 01.06.2008. However, Concurrence of additional 500 additional IT Assistants is not found in the file. Planning Department & Finance Department also sought the clarification regarding technical clearance from IT Department for engagement of 500 IT Assistants and following was informed by Directorate of Education"

"Technical clearance for computer, printer and UPS is already been taken by the IT department, in another file, pertaining to similar project which is under process. However, if required necessary file may be routed from IT Department."

- ii. It seems that instant proposal has not submitted to IT Department by Administrative Department for technical clearance of 1068 IT Assistants earlier.
- iii. Contract of 1068 IT Assistants has already been expired on 30.06.2024.

For 670 IT Assistant:

- i. Department of education has been extending the contract time to time after initial extension in year 2018.
- ii. Last TEC approval of extension was for period 01/10/2022 to 30/09/2023 vide TEC MoM E.-11/4/2020-development/Secy(IT) Vol-2/5801-5810 dated 16.09.2022...
- iii. In the last approval of TEC, it is mentioned that "IT Department need not be approached for further technical clearance- as guidelines for hiring of technical manpower against vacant posts already issued. Further, TEC re-iterated its following advice earlier given vide TEC's MoM dated 10/06/2020: TEC... the Department may take up the matter with AR Department immediately for creation of regular posts".
- iv. Further, it is also observed that DoE had sent the file for TEC approval of 670 IT Assistants for the period w.e.f 01/10/2023 to 30/09/2024 and the same was returned to Administrative Department for further administrative decision and was not placed before TEC.
- v. And Department extended the contract for the period of 01/10/2023 to 30/09/2024 at their end.
- vi. Department has requested to link up the matter of 670 IT Assistants with 1068 IT assistants for conclusive decision.

Now department has submitted the proposal for followings:

- i. Ex-post facto technical clearance/approval for continuation of services of 1068 IT Assistants for the period 2016-2020 & 2020-2024.
- ii. Technical clearance for engagement/continuation of services of 1068 IT Assistants for the period of 01 year w.e.f 01.07.2024 to 30.06.2025.
- iii. In addition of this, Department also sought for Technical clearance for engagement/continuation of services of 670 IT Assistants for the period of 01 year, which has submitted in another file.

The matter may be put before TEC for further discussion on the matter for final conclusion accordingly.

• 2. Delhi e-Governance Society (DeGS), IT Department

The Proposal of DeGS is for Purchase of 05 nos. of Hi-End Desktop Computer and 02 Nos. of Laptop to be use by the Development team of Unified Data Hub (UDH) project in Information Technology Department.

Government of NCT of Delhi is in the process of creating its own Unified Data Hub (UDH) which will act as a Single Source of Truth for applicant's data profile. It will be centralized data repository where data from all departments will be stored, collaborated and updated real time by permissioned entity. It will play a vital role for data analytics, cross referencing and decision making within the department and hence will be a proactive approach for good governance.

In execution and implementation of the same, the two in-house teams have been constituted on Unified Data Hub (UDH), under the chairpersonship of the Joint Director (IT) Department. One team has assigned the technical work related to backend & front end development ie database, API Aadhaar Data Vault integration etc.

In order to smooth development related to UDH, the development team required hi-end 05 nos. of Desktop Computer and 02 nos. of Laptop and these items are to be purchase from GeM portal rule 149 (ii) & as per term condition mentioned in GFR-2017.

In the last weekly status meeting it was decided to start the in-house development of UDH immediately and development team required the hi-end 05 nos. of Desktop Computer and 02 nos. of Laptop urgently required.

In this connection, it is submitted that IT Department has issued a circular dated 13.07.2020 wherein following is mentioned:

"...in order to expedite the approval process, it has been decided that Secretaries of concerned Department having vacant posts of IT cadre may extend the services of such outsourced manpower without seeking clearance of IT Department/TEC for a period not exceeding one year on each occasion or until the posts are filled up on regular basis, whichever is earlier. The terms of initial outsourcing should clearly state the period of engagement is for one year (or less as per the Department's need) OR till the posts are filled up on a regular basis, whichever is earlier. The Terms should clearly state the conditions & period of extensions of services.

The above authorization to Secretaries for extension will be applicable to engagement against vacant sanctioned post under direct recruitment category only. Approval of TEC will be continue to be required for engagement/ extension of staff not against sanctioned direct recruitment category posts."

Sub: - Monitoring of attendance and work done by outsource manpower for NIC projects.

Many departments have hired contractual manpower from NICSI/ICSIL/NIELIT for their e-Governance projects being developed/managed by NIC State Unit, Delhi. The Technical Evaluation Committee of the IT Department recommends the number, designation and duration of engagement of contractual manpower based on the proposal of concerned administrative Department. The responsibility for ensuring that the manpower is physically working for the project for which it has been engaged, is entirely of the concerned administrative Department.

- 2. In view of above, all concerned administrative Departments who have engaged contractual manpower for NIC projects are advised to ensure the following:
 - a. Details of all the manpower (Name, Designation, date of Engagement, Monthly Remuneration etc.) engaged by the Department and deployed with NIC should be available with the Department.
 - b. Monthly attendance should be verified by the Department along with the work done by each individual person.
 - c. The time line of the projects should be adhered by regular monitoring of the project with NIC.
