1. Department of Education, GNCTD

The proposal has been resubmitted by the department regarding Engagement/Continuation of 1068 I.T. Assistants from M/s ICSIL. with the recommendations of Secretary (Education).

The Department has been submitted the following:

- 1068 I.T. Assistants have been outsourced from M/s ICSIL with the approval Finance Department vide U.O. No. 449/DS3 dated 27.03.20214 & U.O.No. 439/DS3 dated 25.03.2014 initially for period of 02 years.
- ii. The agreement has been extended from time to time by the competent authority as per F.D O.M No. F.20/28/2016-AC/634-673 dated 19.08.20216.
- iii. The latest agreement with M/s ICSIL was extended till 30.06.2024.
- iv. These 1068 IT Assistants are not working against any sanctioned post in DoE, as on date.
- v. Discontinuation of these 1068 IT Assistants would standstill the smooth functioning of 1068 Govt. schools as the IT Assistants are backbone of Govt. Schools under Directorate of Education, in as much as IT related work/ computer related work is concerned.

Observation of IT Department:

In light of the matter submitted by the Administrative Department, IT Department observed that:

i. TEC/ IT Department had approved engagement of 568 IT Assistants to be deployed in schools of DoE for effective implementation of MIS project for a period of 04 years vide MoM dated 10.12.2007 w.e.f. 01.06.2008. However, Concurrence of additional 500 additional IT Assistants is not found in the file. Planning Department & Finance Department also sought the clarification regarding technical clearance from IT Department for engagement of 500 IT Assistants and following was informed by Directorate of Education"

"Technical clearance for computer, printer and UPS is already been taken by the IT department, in another file, pertaining to similar

project which is under process. However, if required necessary file may be routed from IT Department."

- ii. It seems that instant proposal has not submitted to IT Department by Administrative Department for technical clearance of 1068 IT Assistants earlier.
- iii. Contract of IT Assistants has already been expired on 30.06.2024. Now department has submitted the proposal for followings:
- i. Ex-post facto technical clearance/approval for continuation of services of 1068 IT Assistants for the period 2016-2020 & 2020-2024. ii. Technical clearance for engagement/continuation of services of 1068 IT Assistants for the period of 01 year w.e.f 01.07.2024 to 30.06.2025.

The matter may be put before TEC for further discussion on the matter for final conclusion accordingly.

2. Delhi Archive

No: DA- E014(64)/2/2016-Records-Part V

The proposal of Delhi Archive is for Proposal for procurement of Sonic Firewall system through GeM for the project of Digitization & Microfilming of archival records of Delhi Archives.

The Department has informed the following:

The instant proposal on the file has been received from Delhi Archives Department through Secretary (ACL) for seeking approval of TEC for procurement of Sonic Firewall system along with 3 years support and service through GeM.

It is observed that department has desire to purchase specific Firewall ie Sonic, instead of other firewall are available on GeM portal. Under which clause of agreement, it is mentioned that firewall has to be purchase by the department instead of vendor, the same has been asked from the department via e-mail. The point wise reply is as:

(a) Why only sonic Firewall needed. There are so many others firewall available on GeM portal.

The Department is only recommending the Sonic Firewall/ NSA 2750 as the same was installed in the past by the Implementing Agency. Further, it is also submitted that any other suitable model which can be utilized as per the specifications can also be explored.

(b) Under which clause of agreement, it is mentioned that firewall has to be purchase by the department instead of vendor.

The Implementing Agency is responsible for firewall and other mandatory hardware/software etc. during the period of implementation of the Project

and not beyond the completion of Project. Hence, agreement does not apply after completion of Project.

(c) Department need to expedite the migration of existing data on the cloud server.

The observation has been noted down and delayed due to the non-posting of IT Cadre staff such DPA, DEO. Once the staff will be posted, the work will be initiated immediately.

As per the Standard Technical Specification for procurement of computer hardware and software issued by Department of Information Technology vide dated 05.04.2023 Router/L3/L2/Switches and other networking equipment, the specification and number may be obtained from NIC Delhi State Unit. Therefore file was sent to seek comments from NIC.

NIC has observed that the website https://archives.delhi.gov.in/abhilekh is currently hosted on local servers managed by third party.

NIC strongly recommends hosting of websites and maintaining servers exclusively in a data centre for enhanced security. This approach offers better protection compared to hosting them locally.

Further NIC advised to migrate the website & local servers data to the already procured servers in the data centre to safeguard against all types of cyberattacks and to ensure proper logging and backup.

The file was returned to administrative department to take action accordingly.

Further, Department of Archive has re-submitted the file to reconsider the proposal for installation of firewall to functional the e-abhilekh portal for the benefit of the general public in large as the portal is nonfunction from last week due to the expiry of licence of firewall.

The proposal is placed before TEC for discussion and appropriate decision.

- II. The portal will be developed by NIC.
- III. IT Department has issued a circular dated 13.07.2020 wherein following is mentioned:

"...in order to expedite the process, it has been decided that Secretaries of concerned Department having vacant posts of IT cadre may extend the services of such outsourced manpower without seeking clearance of IT Department/TEC for a period not exceeding one year on each occasion or until the posts are filled up on regular basis, whichever is earlier. The terms of initial outsourcing should clearly state the period of engagement is for one year (or less as per the Department's need) OR till the posts are filled up on a regular basis, whichever is earlier. The Terms should clearly state the conditions & period of extensions of services.

The above authorization to Secretaries for extension will be applicable to engagement against vacant sanctioned post under direct recruitment category only. Approval of TEC will be continue to be required for engagement/ extension of staff not against sanctioned direct recruitment category posts."

5. Principal and Accounts Office F.No: F(147)/EDP/COA/2024-25

The proposal received from Principal of Accounts Office for obtaining the approval of IT Department/TEC for engagement of 06 technical manpower (02 Assistant Programmer/DPAs & 04 DEOS) on outsource basis from NICSI to set up helpdesk to resolve the queries/doubts/clarification related to "Bhavishya" project of Govt of NCT of Delhi for a period of one year.

Department has submitted that "Bhavishya" an online Pension Sanction and Payment tracking System to be implemented w.e.f. 01.10.2024 in all department of Govt. of NCT of Delhi and Pay and Accounts Offices will process the cases generated in "Bhavishya" through the pension module of PFMS integrated with Bhavishya.
- II. Department has further submitted that more than 1600 DDOs are in Delhi and they will be rewuired to register in Bhavishya

portal at 3 level i.e. HOO,DDO and Dealinh hanf following various steps as below:

- a) Creation of designation based GOV/NIC email ID at 3 level in each DDO.
- b) Registration of Head of Office/DDO//Dealing assistant in Bhavishya portal .
- c) Registration of DDO/PAOs in PFMS
- d) Alignment of DDo code and PAO code as per the standards of CGA.
- III. Further Department has stated that all above works are to be carried out on two portal viz.Bhavishya and PFMS and the department may encounters some queries/clarification during processing the cases and in order to ensure prompt disposal of pension cases setup of help desk has been proposed to resolve the queries/doubts/clarifications.
- IV. Department informed that at present 16 Asst. Programmers have been engaged on outsource basis to manage various system installed in PAOs situated in different locations of Delhi viz IFMS,COMPACT Software, De-Lekha, Government e-Payment Gateway(GePG),GPF System, Pension System, NPS etc. with the approval of FD on recommendation of TEC.
- V. Department submitted that as per IT Department's Circular No. G-17/1/2016-CCU/Secy(IT)/3223-3302 dated 13/07/2020,the approval of IT Department for engagement/extension of staff not against sanctioned direct recruitment category posts is required.
