1. Labour Department, GNCTD

The Proposal of Labour Department is regarding extension of Technical Manpower for the year 2025-2026 which to be deployed in NIC for the development of software for online services of Labour Department. The representatives of the Department explained proposal in detail during the meeting. Based on the deliberations, TEC concurred the proposal for requirement of 01 Developer and 02 Sr. Developer on outsource basis for 11 months.

Further, TEC advised that the Department must observe all codal formalities as per GFR 2017, CVC guidelines and latest instructions issued by Finance and IT Department, GNCTD from time to time.

The representatives of the Department explained the proposal during the meeting and informed that there is requirement of renewal/Hiring of Consultants (02 Nos.) for continuing development of Single Window System(SWS) for Govt. of NCT of Delhi for 11 months on outsource basis.

TEC observerved that Interactive panel components of Smart Classrooms are not classified as IT equipment. Moreover, the Education Department has already prepared specifications through experts hired under the PMU and presented to internal Committee of Education Department. Accordingly, the Education Department may adopt the specifications recommended by the committee as per their Administrative need/requirement with the approval of the Administrative Secretary. Further TEC observed that IT officers of IT Department are already posted in the department therefore such

- i. The Labour Department, GNCT of Delhi is currently implementing and maintaining multiple e-Governance and public service delivery initiatives.
- ii. These initiatives cover a broad spectrum of services delivered through portal like e-District, Online Shops and Establishment, Labour Court Case Management System, Central Inspection System, Payment wages portal monitor and Shops and Exemption portal, among others.
- iii. The department had initially sought approval for the hiring of 05 IT Manpower through NICSI. Based on the approval granted by TEC dated 27.06.2023, out of 05 manpower NICSI is being able to provide only 03 manpower as per the following details, for the reaming 02 manpower NICSI has provided the non- deployment certificate.
- iv. Finance Department also concurred with the proposal for engagement of 05 technical personnel for one year, starting from the date of joining, vide UO No. 131 dated 14.08.2024
- v. Labour Department has been shared proforma for hiring technical manpower via email dated 14.07.2025 with respect to circular dated 28.10.2024. (copy enclosed)
- vi. The projects mentioned by Department i.e. New Web Application for Shops and Establishment, Security Audit for Delhi Labour Welfare Board, Labour Court Case Management System, and Testing & Deployment of new web application and Integration of Shop exemption portal with this new Application of Labour Department is in the pipeline and pending for which NIC requires continues manpower.
- vii. Considering volume of work completed and the works to be completed and to continue the ongoing support for various maintenance activities in Labour Department, it is requested by department to approve the extension of following manpower for a period of one year after the expiry of ongoing 12 months period.

- 1. Technical Evaluation Committee (TEC) granted approval for 05 manpower vide minutes of meeting dated 27.06.2023 for hiring of 05 technical Manpower for a period of 01 year from the date of hiring.
- 2. Based on the approval, out of 05 manpower NICSI is being able to provide only 03 manpower as per the following details, for the remaining 02 manpower NICSI has provided the non- deployment certificate.

- 4. Now, the Labour Department has requested for approval of the extension of 03 manpower for a period of one year after the expiry of ongoing 12 months period.

The proposal of Industries Department, GNCTD is regarding engaging consultant (02 Nos.) for continuing development of Single Window System(SWS) for Govt. of NCT of Delhi. The proposal has been received with the recommendation of ACS(Industries).

The Department has informed the following:-

- i. The SWS is introduced as a focused reform in Business Reforms Action Plan (BRAP) to bring/integrate all departments on one single platform. Department of Industry is coordinating this initiative to implement a Single Window System to assist the investors in the speedy implementation of industrial and other projects in the NCT of Delhi
- ix. The proposed system will provide single point time bound clearances for setting up an enterprise /industry under one roof, thereby reducing the repetitive documentation and number of applications required for taking large number of approval thus ensuring Ease of Doing Business(EoDB)
- x. The period associated with current engagement of consultant is coming to end on 16/07/2025 and there will be lack of consistency in providing appropriate

support/skilled resources. In this connection, hiring of 02 consultants from NICSI empaneled vendor is sought

Comments of IT Department:-

- 1. The proposal is recommended by the Addl. Chief Secretary (Industry).
- 5. Department of Industry, is considering to roll out Single Window System. The proposed system will provide single point time bound clearances for setting up an enterprise /industry under one roof, thereby reducing the repetitive documentation and number of applications required for taking large number of approval thus ensuring Ease of Doing Business (EoDB).
- 6. The proposal for implementation of SWS was placed before TEC held on dated 15/06/2022. The TEC approved the proposal for hiring of 02 consultants for the period of 09 Months. The then TEC approval is reiterated as under:-
 - "...TEC. discussed the proposal of Industries Department, as per detail given in the TEC agenda item no 2 mentioned in attached Annexure-I. After deliberation in TEC meeting and inputs received from the representatives of the Industries Department, TEC technically concurred the requisite infrastructures proposed for implementation of Single Window System along with hiring of 02 Nos of Consultants (For a period of 09 Months as proposed by department) from NICSI empanelment. However, the in-principle approval of concerned minister is still required though TEC has cleared the proposal of Single Window System..."
- 7. Accordingly, Industries Department had engaged the 02 consultants through NICSI fro SWS w.e.f 05/12/2022 to 03/09/2023 with the ex-post facto approval of the Hon'ble LG. This tenure was further extended up to 16/07/2025 with the approval of Hon'ble Minister (Industries), which is further extended up to 31/08/2025. The matter only has put once before TEC held on 15/02/2022 for hiring of 02 consultants for the period of 09 Months.
- 8. The department has submitted the afresh proposal for hiring of 02 consultant through NICSI for one year extended by another year on existing T&C subject to satisfactory performance under category 1 (technical manpower without Sanctioned Post) with duly signed information sheet, Project and manpower

- requirements and post status as per Annexure-I & II in their department as sought in IT Circular dated 11.03.2025.
- 9. As per the AR Circular issued vide No. F.14/03/2015/AR/254-315 dated 09.10.2015, IT Consultants may be hired as per NICSI empanelment however, the in-principle approval of concerned minister is required even after the Technical Clearance of the IT Department.

In view of the above, the proposal of Industries Department seeking approval of TEC for engaging consultants (02 Nos) for continuing development of Single Window System (SWS) for Govt. of NCT of Delhi, is placed before the TEC for consideration.

3. Department: Education Department

(F.No. F.1(01)/PMU/Tender.IB/2025-26) (Comp. No.-243617)

The proposal of installation of 3000 Smartboards/Smart Interactive Panels in 75 CM Shree Schools of Delhi Govt., has been received with the recommendation of Secretary (Education).

Department has submitted followings:-

- Directorate of Education is in the process of setting up of Smart Classrooms in CM Shree Schools in Delhi under DOE. In this connection, 3000 Smartboards/Smart Interactive Panels will be installed in 75 CM Shree Schools of Delhi Govt.
- 2. The proposal was submitted by DDE (CM Shree School) and Tender document has been prepared by the Management Consultants, hired by NICSI.
- A meeting of approval committee was called on 01/07/2025 at 4:00PM for examination and approval of draft tender documents prepared by management consultants.
- 4. Tender document has been approved by approval committee, is placed opposite at 104- 04/C. Minutes of meeting for the said meeting is placed in the file.
- 5. Although the Approval Committee has approved the Tender Documents alongwith specifications of the times to be procured, however, para 3 of circular No. F.No. E11/4/2020-Dev-Secy(IT)/Vol-3/1478-1547dated 11.03.2025 of IT Department provides that "Procurement of other IT Hardware, other than those covered under Annexure-1, shall be mandatorily referred to the Department of Information Technology, GNCTD Delhi along with requisite justification, for technical clearance and only subsequently procured subject to further financial concurrence by the competent authority
- 6. It is also mentioned that Jt. Director, IT, DOE was one of the members of the Approval Committee and his observation is recorded in the file and is as under (Note#4 of the attached file):
 - "as per the latest guidelines for Purchase of IT equipment issued by the IT Department vide letter dated 11.03.2025, the specifications of Smart Boards has not been mentioned under the Standard Specification of the IT

Equipment's." He further recommended to forward the proposal to IT Department for approval of technical specifications".

Observation of IT Department:

- 1. The file has been resubmitted with the approval of Secretary (Education).
- The Department is in the process of setting up of Smart Classrooms in CM Shree Schools in Delhi under DOE. In this connection, 3000 Smartboards/Smart Interactive Panels will be installed in 75 CM Shree Schools of Delhi Govt.
- 3. The specification of smart boards/Smart Interactive Panels are not mentioned in the IT Department Circular issued vide dated 11/03/2025.
- 4. The requisite specifications of interactive panel is attached as reference.

In view of this, the matter may be put up before TEC for further discussion.

4. Department: Revenue Department

(File No: RD-G/1/2025-IT-REVENUE DEPARTMENT) (Comp. No. 238144)

Subject: Setting up of local team (01 DBA and 02 Programmer) for NGDRS, Delhi portal.

The proposal received from Revenue Department is regarding seeking technical clearance of IT Department for setting up of the Delhi local-team for the NGDRS, Delhi portal by hiring manpower(01 DBA and 02 Programmer) from NICSI for 02 Years for development related activities need to performed in NGDRS, Delhi portal such as development/ incorporation of various software modules (model deed writer, prohibited property module etc.), MIS, interactive and cascading Dashboard, advance/filter based search facility etc. In portal of Revenue Department. A link file having File No. RD-G/1/2025-IT-REVENUE DEPARTMENT is also linked with this file. The proposal has the approval of Dy Commissioner -V(HQ) (Revenue).

The department has informed the following:-

- a) A lot of development related activities need to performed in NGDRS, Delhi portal such as development/ incorporation of various software modules (model deed writer, prohibited property module etc.), MIS, interactive and cascading Dashboard, advance/filter based search facility etc.
- b) While it has been observed that a local team of NGDRS, Delhi should be available for mitigating the gaps in communication and esp. in light of the view of the NGDRS team (i.e. NIC Pune) that for development of Dashboard, reporting systems (MIS) and other local requirements, a local team may be setup. Accordingly, NGDRS team, NIC Pune was requested to set up a local team in Delhi for this purpose.
- c) Setting up of the Delhi local-team for the NGDRS, Delhi portal by hiring manpower from NICSI.
- d) A team of professionals including PostgreSQL DBA, System Admin, PHP Developer should be constituted to form a local team for NGDRS, Delhi version. Considering the scale, size and sensitivity of the NGDRS, Delhi portal, Tier-2 Level-8 category of manpower are being proposed for hiring.

- e) Training will be given to the hired professionals by the NIC, Pune team professionals after setting up of local team.
- f) Technical Director NIC Delhi added that, NIC, Delhi state unit is ready to take up the matter of setting up of a local team by hiring professional through M/s NICSI however it has been categorically mentioned by him that as experienced during DORIS-era that due to long delays in getting necessary approvals for continuing the project including for hiring of manpower, project suffers heavily as the trained professionals, working on the project, tend to leave the project; and which he insisted that it should not be the case this time.
- g) NGDRS, Pune team vide above mentioned letter dt. 23.06.2023, have already communicated the roles responsibility; segregation of work among NGDRS Pune and local team
- h) State Govt./UTs (Assam, Jammu and Kashmir etc.) have already setup their local team by hiring professionals.

The proposal has been examined and observed the following:-

- a) The proposal has been received with the recommendations of Dy Commissioner -V(HQ) (Revenue).
- b) Revenue Department has sought technical clearance for hiring of manpower(01 DBA and 02 Programmer) from NICSI for 02 Years. However, as per circular dated 11.03.2025 issued by IT Department, the manpower hiring duration shall not be greater than 11 months.
- c) Department has provided the manpower detail and technical information of the project as required for TEC.

In view of above, proposal of Revenue Department for setting up of local team (01 DBA and 02 Programmer) for NGDRS, Delhi, portal is placed before TEC for consideration.
