Governor, Delhi is pleased to appoint on promotion the following Data Processing Assistant, Group 'B', Gazetted in the Pay Level 07 as per 7th CPC to the post of Assistant Director(IT)/System Analyst, Group 'A', Gazetted in the Pay Level 10 of the Pay Matrix as per 7th CPC plus usual allowances as admissible under the rules **notionally w.e.f. 07.09.2017** and actually w.e.f. the date of assumption of duties of Assistant Director (IT)/System Analyst:

2. The above-mentioned officer may exercise his option, if any, within one month in pursuance of the instructions of Government of India regarding fixation of pay as contained in FR-22. The actual benefit of promotion will be admissible to the above-mentioned officer only with effect from the date of his joining to the post of Assistant Director (IT)/System Analyst.

3. Consequent upon his promotion from the post of Data Processing Assistant to the post of Assistant Director (IT)/System Analyst, the officer, after being relieved from his present department DT & T will submit his joining in IT Department. His further posting orders will be issued subsequently as per decision of the Competent Authority. During this period of under posting, he will continue to physically work in his present department i.e. Department of Trade & Taxes.

4. **The Head of Department concerned should ensure that above-mentioned officer is clear from vigilance angle before relieving him for joining as Assistant Director (IT)/System Analyst. If the officer mentioned above is not clear from vigilance angle or facing criminal proceedings in any Court of Law or has resigned/relieved/expired etc., the same should be brought to the notice of this department immediately.**



5. The benefit of promotion will be admissible to the aforementioned officer only with effect from the actual date of joining to the post of Assistant Director (IT)/System Analyst. .

6. The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Others (Civil Appeal No. 629 of 2022) arising out of SLP(C) No.30621/2011 as conveyed by the DoPT vide OM no. 36012/16/2019-Estt.(RES) dated 12.04.2022.
