On the recommendations of the Departmental Screening Committee (DSC) constituted for grant of financial upgradation under Modified Assured Career Progression (MACP) Scheme to the eligible Retd. Joint Director (IT), Group-'A' Gazetted of IT Cadre of Govt. of NCT of Delhi. In accordance with the instructions contained in the OM No. 35034/3/2015-ESTT.(D) dated 22.10.2019 of Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), as further endorsed by Deputy Secretary (Finance-Budget), Government of NCT of Delhi vide endorsement No. F.(21)/FIN.(ESTT.-III)/07CPC/2016/1984 dated 16.12.2019, the approval of Hon'ble Lt. Governor, Delhi, is hereby conveyed for revising the dates of 2nd and 3rd financial upgradation under MACP Scheme (as applicable), in the immediate next higher level of Pay Matrix, for the following IT Cadre Officer, as per the details given below:

The officer concerned may be allowed to exercise his option, if any, under FR-22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme (MACPS).

The grant of higher pay scale / level in Pay Matrix is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The concerned Heads of Department are requested to ensure before issuing the final order that 10/20/30 years continuous regular service of officer does not include the period of service rendered in State Government / Statutory body / Autonomous body / Public Sector Organisation as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No. 10 of DoP&T's O.M. dated 22.10.2019).

The concerned Head of Department is also requested to issue formal order for grant to revise the dates of financial upgradation in respect of the above mentioned officer retired from his department. Before issuing such order, the Head of Department shall ensure that the officer has completed 10 years of regular service in the present grade/ Pay Scale/ Pay Matrix level on the effective date of grade of financial up-gradation without promotion and is clear from vigilance angle.
